- O3.3: Optimization and production of the final version of the output (September, 2019)

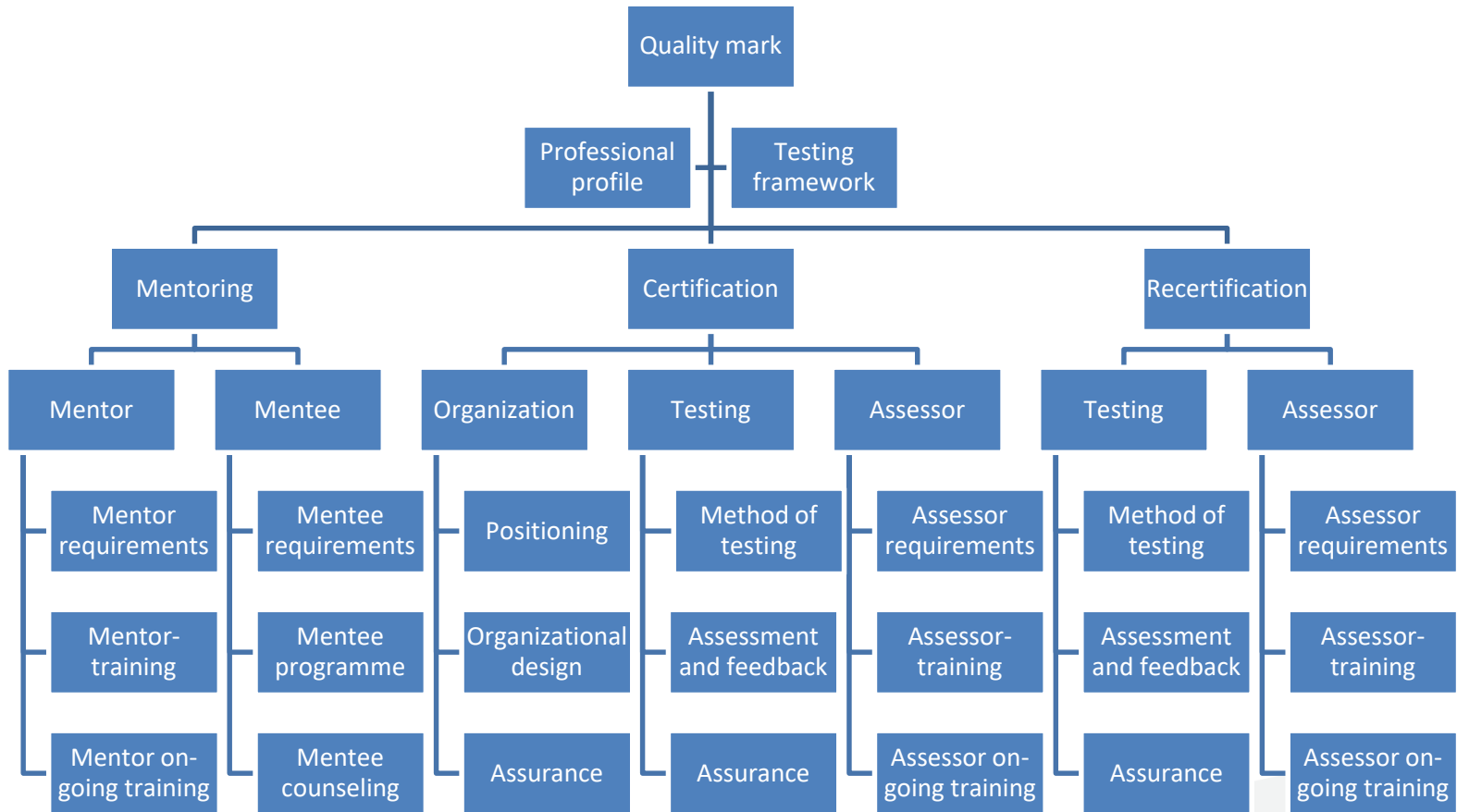
